SUBJECT: Report on West San Carlos Joint Venture Public Meetings

BACKGROUND:

At its February 7, 2008 meeting, the Board of Directors authorized the General Manager to extend the exclusive negotiating period with Green Republic, LLC, the selected developer on the West San Carlos Joint Development Project, for up to 90 days. This action stipulated that Green Republic hold three public meetings within 60 days, notify all residents and landowners within 1000 feet of the parcels of the public meetings, and provide a report of the meetings to the Board in 60 days.

DISCUSSION:

Following the February Board meeting, Green Republic hired the public relations firm of BergDavis to organize and facilitate the public meetings. In addition to the minimum number of meetings and the notification requirements specified in the Board action, Green Republic / BergDavis are pursuing two additional meetings as shown in Attachment A. As a first step to organizing this process, BergDavis contacted all the neighborhood associations represented at the February meeting. These groups expressed a preference for the public meetings to occur as part of their regularly scheduled meetings; however, several of the neighborhood associations had set the March meeting agendas in February. As a result, meetings for those groups had to be set for early April. In addition, BergDavis has been coordinating closely with Supervisor Ken Yeager and San Jose Councilman Pierluigi Oliverio's office to ensure that they can attend as many meetings as possible.

At the March CMPP meeting staff will provide a verbal report of the meetings to date. A further report with a written summary will be provided to the Board of Directors at its May meeting.
