



## VTA Construction Update

### **SAN CARLOS STREET RAIL REPLACEMENT**

#### **West of Market Street to Convention Center Station Weekend of October 31, 2009**

Issued October 5, 2009

The following will be in effect as indicated; administrative permits, weather and other conditions permitting.

**OVERVIEW:** Light rail track at two intersections along San Carlos Street in downtown San Jose requires replacement. The work will be done over three consecutive weekends in Late October and early November. Crews will work at the Market and San Carlos streets intersection the first weekend, then on track west of Market Street extending toward Convention Center Light Rail Station the second and at the Almaden Boulevard and San Carlos Street intersection the third weekend.

In order to minimize impacts to downtown employers, educational institutions, commuters, hotel guests and transit users, the work will be done each weekend from 9 p.m. Friday to 3 a.m. Monday morning. Some nighttime activities will take place at each site for up to two nights before the weekend.

Short-term construction impacts to the surrounding community include daytime and nighttime noise from sawcutting, demolition and replacement of concrete and the removal and replacement of light rail tracks.

In addition, when work is taking place at either intersection, traffic and pedestrians will not be able to cross San Carlos Street and instead will be detoured one block in either direction. San Carlos Street will remain open to through traffic. Additionally the Convention Center Light Rail Station will be closed each weekend, with VTA providing impacted riders a free courtesy bus trip around the closed station and construction site.

Long-term benefits to the surrounding community include quieter light rail operations.

**WHERE:** Trackway located west of Market and extending toward the Convention Center Light Rail Station.

**WHEN:** Construction activities will begin at 9 p.m. Friday, October 30 and continue to 3 a.m. Monday, November 2. Also, some night work (concrete sawcutting) on the preceding evenings of Wednesday/Thursday and Thursday/Friday is scheduled.

**WHAT:** Continuous construction activities will begin late Friday night and will include the removal of the rail tracks and demolition of the adjacent concrete, earthwork, and the installation of new track and pouring of new concrete.

**LANE CLOSURES:** The lane of traffic closest to the light rail tracks on San Carlos Street will be closed, with at least one lane for through traffic remaining open at all times.

**DETOUR:** No detours are anticipated for this weekend because there are no planned partial intersection closures.

**WHAT:** Modifications to the crosswalk crossing San Carlos Street and serving the east end of the Convention Center Light Rail Station will be made.

**WHERE:** The crosswalk is located on San Carlos Street midway between Market Street and Almaden Boulevard.

**WHEN:** Saturday, October 31 and Sunday, November 1.

**LANE CLOSURES:** Please see the lane closure description for the track replacement work this same weekend.

**DETOUR:** No detours are anticipated for this project.

For the safety of the public and construction workers, traffic control measures will be used when needed. Informational and warning signs will be posted as necessary to ensure everyone's safety. Construction crews will make every effort to maintain access and minimize inconvenience to businesses, motorists, cyclists and transit riders.
