




VTA's Role in Santa Clara County

VTA is more than buses and light rail. As the County Transportation Agency for the County, we also:

- Act as a funding conduit for local cities and other agencies
- Design and build transit facilities, highway improvements, and expand rail service
- Plan for congestion management and landuse
- Design, build and own BART to Silicon
 Valley infrastructure in Santa Clara County

The Valley Transportation Plan (VTP) is an important step to developing and delivering many of these projects and programs.

Today's Goal

The Visionary Network and Valley Transportation Plan 2050 are long term plans that will impact:

- Transit and service needs
- Roadway and highway commuting issues.
- Creating safe bike and pedestrian transportation networks
- Housing near transit
- Developing near priority areas

VTA's Vision will be guided by community feedback, equity, and by making sure that planning aligns with future population and housing growth, and transit and transportation needs that will serve the community for the next 30 years and beyond.



What is VTP?

Valley Transportation Plan 2050 (VTP) is the longterm plan for transportation, land use, transit, and bicycle and pedestrian planning.

The VTP:

- Identifies transportation projects and programs
- Prepares agencies to secure funding for these projects
- Considers all types of travel transit, bike and pedestrian, highways, local streets and roadway
- Will be included in Plan Bay Area updates

The Visionary Network will define how transit service in Santa Clara County should look over the next 30 years, including:


- Street corridors it should serve in the future

- What bus stops and stations should look like and provide






What is VTA's Visionary Network?

What We're Hearing So Far for Your Vision for Transit:







Upcoming Project: Equitable VMT Mitigation Program

VTA was recently awarded a Caltrans planning grant for an 'Equitable Vehicle Miles Traveled (VMT) Mitigation Program for Santa Clara County'

- Goal: develop framework for a program to reduce the amount of driving from land development projects, in a cross-jurisdictional and equity-focused way
- Program could help streamline housing production and generate revenue for transportation improvements, such as:
 - Improved sidewalks and bicycle lanes
 - Improvements to speed up buses at intersections
 - Free transit passes or bike share memberships
- Grant project will run from Spring 2023 through Late 2024



Equitable VMT Mitigation – Opportunities to Get Involved

1. Participate in work as part of the project team:

- VTA issued a Request For Proposals (RFP) on November 23, 2022
- Community-Based Organizations may be included on teams as subcontractors or as team members compensated via stipend
- Organizations should contact the shortlisted firms about potential teaming; email Norman David (<u>norman.david@vta.org</u>) for contacts or questions
- Proposals are due December 22, 2022

2. Help spread the word and provide input more informally

- Opportunities to spread the word and provide input through your members / communities
- Anytime over the course of the project (Spring 2023 Late 2024)
