



## Notice of Availability: Supplemental Draft Environmental Impact Statement

The Santa Clara Valley Transportation Authority (VTA) is proposing to extend light rail by 2.3 miles along Capitol Expressway between the existing Alum Rock Light Rail Station and Eastridge Transit Center. New light rail stations will be located at Story Road, Ocala Avenue, and Eastridge Transit Center.

VTA has prepared a Supplemental Draft Environmental Impact Statement (EIS) for the Project in accordance with current federal environmental laws and guidelines. The Draft EIS presents alternatives for the project and discloses the environmental impacts of those alternatives. The potential environmental impacts are: increased delay at various intersections, increased carpool and bus travel times in the corridor, exposure to severe vibration levels during operations and construction, and exposure to severe noise levels during construction. The Draft EIS also includes a project-level air quality conformity analysis, which shows that the Project will conform to the State Implementation Plan, particularly for carbon monoxide and particulate matter for which the Bay Area is in maintenance and not-attainment status respectively.
