SUBJECT: VTA Ridership for January 2020

January 2020 total monthly system ridership for bus and light rail was 2,844,461, a slight decrease of 0.5% over January 2019. Bus ridership was down by 1.4% compared to January 2019. Light Rail ridership was up by 2.3% compared to January 2019. January 2020 total monthly ridership recorded a 2.3% increase compared to December 2019. Ridership change from December to January typically averages -1.0%.
