COVID-19 testing is free, easy, and safe. If you are unable to visit one of the three sites listed above, you can schedule an appointment at one of the permanent locations below.

City Locations

Various testing sites in the following cities will offer scheduled walk-up testing Monday through Friday for people without symptoms only: Campbell, Cupertino, Los Altos, Los Altos Hills, Los Gatos, Milpitas, Morgan Hill, Mountain View, Palo Alto, Santa Clara, Saratoga, and Sunnyvale.

El Camino Health – Los Gatos Hospital

This location offers free testing for people who do not show symptoms of COVID-19. Appointments will be open for scheduling seven (7) days before the testing date and can be scheduled by clicking [here](#) or calling 650-940-7022 and selecting option 4. Once all appointments are filled, this location will no longer appear for scheduling on the website.

This location offers free testing for people who do not show symptoms of COVID-19 and live, work, or go to school within the El Camino Healthcare District, which includes most of Los Altos, Los Altos Hills, Mountain View, and Sunnyvale, as well as small sections of Cupertino, Palo Alto, and Santa Clara.

Santa Clara County Health and Hospital System - Valley Medical Center (VMC)
Locations

Valley Medical Center is currently offering testing at one drive-through site in Santa Clara County. Anyone can be tested, and there are no requirements for testing criteria or insurance. Appointments are available on the days and times specified below.

COVID-19 testing is also available through your healthcare provider.

Large healthcare systems, including the County of Santa Clara Health and Hospital System, Kaiser Permanente, Palo Alto Medical Foundation, Stanford Healthcare, El Camino Hospital, Good Samaritan Hospital, and Regional Medical Center are all required to test the following three categories of patients:

1. All patients with COVID-19 symptoms

2. All patients who have had close contact with a person who tested positive for COVID-19
3. All patients at higher risk of exposure to COVID-19 because they work in front-line settings, regularly ride mass transit, or have recently attended a mass gathering.

As mentioned above, all VTA staff without symptoms of COVID-19 are advised to visit one of the following temporary locations to get tested. This is especially urgent now considering the number of cases in the Bay Area has been increasing, and it is important to note that people do not need to show symptoms to spread the virus. In fact, of those who spread the virus:

41% are symptomatic,

35% are pre-symptomatic,

and 24% are asymptomatic.
