Santa Clara Countywide VMT Evaluation Tool – *Version 2*: Quick Start Guide

(September 24, 2021)

Thank you for your interest in the Santa Clara Countywide Vehicle Miles Traveled Evaluation Tool (VMT Evaluation Tool), brought to you by the Santa Clara Valley Transportation Authority (VTA), in collaboration with the 15 cities and towns of Santa Clara County, and the County of Santa Clara. Version 2 of the tool, released in September 2021, can be accessed at wmttool.vta.org.

WHAT DOES THIS TOOL DO?

The VMT Evaluation Tool is designed to assist you in screening and estimating project-generated VMT for certain types of land use projects in Santa Clara County, and calculating VMT reductions associated with certain VMT-reducing measures. The tool is intended for use on three primary land uses:

- Residential
- Office
- Industrial

The tool evaluates projects with one or a combination of these uses, with or without local-serving retail.

LIMITATIONS OF THE VMT EVALUATION TOOL

The VMT Evaluation Tool only covers some of the possible screening criteria that a city or county may establish for land use project VMT analysis per California Senate Bill 743. Other land uses types, large or complex projects, or long-range land use plans will likely require other methods for VMT analysis. Before making any decisions using the information provided by the VMT Evaluation Tool, it is recommended that you contact the city/town/county in which the proposed development is located. Please refer to the *User Agreement* dated May 20, 2020 (available within the tool at wmttool.vta.org) for more information.

RUNNING THE VMT EVALUATION TOOL – 4 BASIC STEPS

The following are the four basic steps involved in running the VMT Evaluation Tool:

1. Select Project Area 2. Determine **Screening Inputs** Choose what "rules" to follow, select the parcel(s) Select what land uses that make up your project to analyze, data and site, and view related threshold to use, and map layers other parameters 3. Land Use Info & VMT 4. Results / Report Reductions View results in table Enter residential units and and bar chart form, non-residential square download a PDF footage, and select VMT report, and export CSV data tables reduction strategies

If you only wish to screen a site (i.e., determine whether it is in proximity to transit and/or in a low-VMT area) you may skip Step 3 by clicking the "Project Screening Only" button on the second screen.



READING THE REPORT & EXPORT FILES

The VMT Evaluation Tool produces two types of outputs: a formatted report, which shows up on the Results screen and can be downloaded as an accessible PDF file, and data tables including all the user-provided inputs and the back-end data which can be downloaded as CSV files.

Key things to look for in the report / PDF:

Whether the project falls in proximity to transit (within ½ mile of a Major Transit Stop, or ½ mile of a stop along a High-Quality Transit Corridor as defined in state law): Look for the 'Proximity to Transit Screening' section on Page 1 of the report.

Proximity to Transit Screening Inside a transit priority area? Yes (Pass)

• Whether the project falls in a low-VMT area (i.e., below the VMT threshold specified by the city/town/county): Look for the 'Low VMT Screening Analysis' row on the Screening Results page(s) of the report, starting on page 2. There will be Low-VMT Screening results for each land use you select.

The CSV files are intended to help the user understand how the VMT reduction results were obtained; the data in the files, along with the formulas in the forthcoming User Manual, should help confirm the results.

TIPS FOR SUCCESS

• Fields that require an input are generally marked with an asterisk (*). Look for the "tool-tips" | across the tool to help you understand the input fields.



- The tool may take 3 to 5 minutes to run a report; if you've waited much longer, refresh and try again. You may want to avoid running other processes while the tool is generating the report.
- If you are running variations of a project, use the back arrows in the upper-left of each screen (such as tedit inputs) to go back, vary some inputs, and run the report again.
- The tool is optimized for Chrome, Firefox, Edge or Safari on a Windows or Mac computer, although you may also access it from a tablet or another browser.
- Please fill out the short feedback form by clicking on the link REPORT A PROBLEM/FEEDBACK in the upper-right of the screen. You may report errors, rate the tool, and offer suggestions for future improvements.

FOR MORE INFORMATION

VTA has provided further documentation of the VMT Evaluation Tool in a Frequently Asked Questions (FAQ) document, and we anticipate releasing a full User Manual in late 2021.
