
### **FTA Update**

### Path to FTA Full Funding Grant Agreement







## **Funding Status**



- Federal Transit Administration (FTA) announced that \$500 million is officially in the Federal FY24 budget for this project
- The next six months are very critical for VTA in securing the Federal funding
- Raising project need, benefits, and visibility from a County, State, and Federal level is critical during this period
- Our Congressional Delegation needs to hear about the tremendous support for this Project from all levels of the community – including residents, community stakeholders, businesses, and elected officials
- The project has had strong local backing since 2000 and VTA is here to deliver it





# Downtown San José Station

### Downtown San José BART Station



- 1. Establish a project plan to realize the Downtown San José south entrance outside of the federal project, that would result in the entrance opening concurrently with the overall BSV Phase II project Revenue Start Date.
- Identify an initial phase of work for the DTSJ south entrance project that could commence immediately thereafter, and program staff and funding (separate from the federal BSV project) to carry out the south entrance through the environmental phase.
- 3. Identify a long-term funding strategy for the DTSJ south entrance.
- 4. Ensure that both the north and south headhouses strive for the highest level of iconic, context sensitive design, including art and design cues from the surrounding Downtown community.



## **Diridon Station**

### **Diridon BART Station**



- 1. Locate BOH underground.
- 2. If all options in attempt to locate the BOH underground have been exhausted, then:
  - a) Provide an in-depth presentation to the Oversight Committee and Diridon & Downtown Community Working Group on the reasons why; including a comparison with Downtown San José Station and its BOH location; and
  - b) Line the edges of the BOH with active, ground-floor space such as retail along its sides facing Cahill St and Montgomery St; if this cannot be accommodated, provide an alternative plan for how the above-ground BOH facility will be activated at street-level and vet this with City, Oversight Committee, and Community Working Group.
- 3. Redesign the tunnel to facilitate a future passenger connection to the Diridon Intermodal Facility; specifically, work with the Diridon Integrated Station team to identify a location for a knock-out panel and include the knock-out panel and mezzanine extension the BSV project design.

### **Station: At-Grade Facilities**



- To ensure project funding, an evaluation was conducted in Fall 2023 to identify changes that would reduce project costs to maintain feasibility
- At-Grade Station infrastructure facilities modifications were identified as solutions
  - Capital Cost Savings: major temporary structure reduction (shoring), significant permanent structure reduction (walls and floors), removal of elevators and staircases
  - Long-term Operational Savings & Efficiencies: reduces waterproofing issues and easier access to large electrical and mechanical equipment

### **Station: At-Grade Facilities**



- Station Infrastructure Facilities need to remain close to station entrance due to critical roles:
  - General and Emergency Ventilation systems require connection to the tunnel with ductwork (exhaust/intake fan plant systems)
  - Fire protection systems and emergency monitoring including backup power sources (battery and generators)
  - Electrical and communication cables that power BART trains and stations
  - Proximity to headhouse is critical for prevention of voltage drops, signal loss, and reduces length of copper cables (1,000's of cables and connections traverse from the systems area within the Station Infrastructure Facilities to the Tunnel)
  - Station Infrastructure Facilities can be separated from station building by no more than 30'



## **Initial Activities at West Portal**





- Site grading will begin in May and may produce vibrations and noise during the day.
- Where applicable, BSV is facilitating ongoing construction coordination and updates between contractor and stakeholders
- CTMP covering this work was brought to Councils and approved in June 2023

### Info Shared on Construction Notice



- WHAT summary of construction activity
- WHERE location of construction activity with map
- WHEN include interval of dates and times, include a note if it includes weekend and/or nighttime work
- WHAT TO EXPECT includes information on the activity and impacts (noise, dust, sidewalk closures, parking impacts, bus stop relocations, road detours, etc.)

### Notice of West Portal Site Work: Week of April 22, 2024

### WHAT

- To assist in the beginning of construction work at the West Portal site within the future Newhall Yard & Maintenance Facility, VTA's BART Silicon Valley Phase II (BSVII) project workers will be on site the week of April 22, 2024, to install project equipment comprised of noise, vibration, and air quality monitors.
- The Newhall Neighborhood may witness BSVII project workers within the neighborhood to install project equipment on the Dahlia Loop and De Altura Common, for no more than 2-4 hours at a time.

### WHERE

- The West Portal site within the future Newhall Yard & Maintenance Facility.
- Newhall Neighborhood roadways including Dahlia Loop and De Altura Common.

### WHEN

 All work will be conducted between 9 am and 5 pm, from Monday, April 22, 2024 – Friday, April 26, 2024.

### WHAT TO EXPECT

 BSVII project construction workers to be onsite at variable hours the week of April 22 to install construction equipment.

### PROJECT BACKGROUND

VTA's BART Silicon Valley Phase II Extension (Phase II Project) is a six-mile, four-station extension of BART from Bernyessa: Alvorth San José Station (opened 2020) through downtown San José to the City of Santa Clara. The Phase II Project is planned to include an approx. five-mile subway, three stations with underground platforms (28th Street/ Little Portugal, Downtown San José, and Diridon), one ground-level station (Santa Clara), a train maintenance and storage facility, and additional facilities.



Area of project equipment installation

Construction is a dynamic process and information is subject to change without notice.











### **Distribution Methods**



### **Electronic Distribution**

- Distribute via MailChimp to all stakeholders
- CWG members, City districts, neighborhood associations, targeted stakeholders (e.g., PayPal Park), and residents

- VTA inputs information in transit apps, 511, and mapping apps
- VTA notifies transit riders for bus stop relocations, etc.


