Happy to see that there is a BRP. This is something that won't happen until we break ground, right? It's just the planning stage of what the resource and program will be

- Early construction is anticipated to start in 2023
- Planned to have the program ready to support those businesses when we begin construction
- Preliminary efforts to ensure program meets needs & further analysis on what's already developed
- Requires better sense of the proposed delivery methods & various access types to businesses, sidewalk closures, and intermittent closures that may reduce access to businesses.



VTA's BART Silicon Valley Phase II

The largest single public infrastructure project ever constructed in Santa Clara County, VTA's BART Silicon Valley Phase II Project (Phase II) will extend BART service six-miles from the Berryessa Transit Center into downtown San José and ending in the City of Santa Clara.



This video provides an overview of the project alignment including concepts under development. Elements are subject to change. It should be noted, certain design elements may require further environmental analysis under CEQA/NESA, which, to the extent required, would be completed prior to approval by VTA of any contract that includes any such design elements.

Phase II is estimated to carry 54,600 passengers each weekday to destinations throughout the Bay Area by 2040. Completion of the project will finally "ring the bay" with frequent rail service.







Recent Project Highlights



Monthly meetings with FTA on Full Funding Grant Agreement (FFGA)



Additional \$200 million allocated for the project in President Biden's proposed upcoming Fiscal Year 2023 budget



Real estate acquisition process progressing with negotiations underway



Second round of cooperative agreements with Cities of San Jose and Santa Clara being finalized; targeting execution Q2 2022



Continued ongoing technical coordination with partner agencies and third parties



Conducted a stations workshop with SPUR, City of San Jose and BART staff



Project update to the joint VTA/BART Working Committee consisting of Board members from both agencies



- BSVII project funding is critical focus for VTA
 - Current funding projections assumed \$6.9 Billion
 - Federal estimates reflect \$9.1 Billion
 - VTA working toward funding the full \$9.1 Billion as the ceiling
 - Key driver will be increasing federal participation
- BSVI & BSVII O&M
 - Projections being updated – costs, schedule, etc.
 - Funding “shortfall” reference has been specific to 2008 Measure B funds
 - Mechanism in place to ensure full funding of agreed-to O&M expenses

General Scope*

- Tunnel & trackwork
- Mid-tunnel facilities
- 28th Street/Little Portugal support of excavation
- Utility relocations (as required)
- Stations Support of Excavation & Connecting Adits

Stage 1

- Includes collaboration between the contractor, VTA, BART, the City of San Jose, & the community
- Review of proposed innovations & further advance design to prepare a final construction bid
- Determines
 - Final configuration within the limits of the currently approved project
 - Total construction cost
 - Schedule for completion of the Stage 2 construction work



Stage 2

- Progressive Design Build Contractor will provide a proposal that includes construction cost, schedule, & risk mitigations
- Advance the design to 100% & complete construction of the CP2 Contract

- At the [VTA Board of Directors meeting](#) on May 5th, 2022, the VTA Board unanimously **voted to award** the Tunnel & Trackwork Contract Package (CP2) for VTA's BART Silicon Valley Phase II Extension Project.
- CP2 will be delivered through Progressive Design-Build via two stages. This award includes initial Stage 1 services and is the first request of a series of Board Award authorizations for CP2 that will occur from May 2022 through approximately December 2023.





Authorize the GM/CEO to execute a progressive design build contract with Kiewit Shea Traylor, a Joint Venture (KST), in the amount of \$235M to perform Stage 1 Services for CP2. Additional allowances up to \$19M for surety bonds and initial early work packages.

-  Issue a Limited Notice to Proceed to investigate design alternatives and innovations to determine potential cost/schedule savings
-  Collaborate and continue working with BART, CSJ, CSC, and other stakeholders of innovations and advancing design concepts
-  Present an update on CP2 and potential innovations to VTA Board in September

Additional approval and request to review previously completed assessments comparing single & twin-bore tunnel methodologies, in a parallel track moving forward with the initial contract work.



Construction Transportation Management Plan (CTMP) Process

Erica Roecks, VTA



Draft CTMP

- Created by VTA, the City of San José and the City of Santa Clara jointly to minimize public disruptions as required in the SEIS/SEIR (environmental document)
- Includes Final Emergency Services Coordination Plan (ESCP) as an appendix
- Included in CP1, CP2, CP3, and CP4 contract specifications



Contract-Specific CTMPs

- Developed by the individual contract package teams, collaboratively with VTA, the City of San José and the City of Santa Clara
- Builds from the draft plan and contains site-specific details for mitigating public impacts
- Includes Final ESCP as an appendix



TCPs

- Based on Contract-Specific CTMPs
- Site specific requirements on access routes, signage, notifications, parking, etc.

CTMP Development Schedule



- Coordination with Cities
- 161+ relevant comments received during the 2018 environmental process

- Access & Service Needs Interviews with businesses and institutions
- 53+ interviews with businesses, institutions, and other key stakeholders

- Coordination and review with Cities
- 10+ presentations to Community Working Groups, Small Business Taskforce, and City staff

- Coordination between VTA, Cities, and Contractors
- 40+ community/ stakeholder construction meetings and events anticipated
