The California Department of Transportation (Caltrans), as the lead agency under the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA), has prepared a Draft Environmental Impact Report (EIR)/Environmental Assessment (EA) for the I-280/Winchester Boulevard Interchange Improvements Project. The project description, location, public review dates, public meeting information, summary of significant impacts, and other information, is provided in the enclosed materials.

# I-280/Winchester Boulevard Interchange Improvements Project

## WHAT IS BEING PLANNED?

Caltrans, in cooperation with the Santa Clara Valley Transportation Authority (VTA) and the City of San José, proposes to modify the existing I-280/Winchester Boulevard interchange by constructing a new tunnel off-ramp from northbound I-280 toward Winchester Boulevard. The Project would also construct a new direct connector ramp from northbound SR-17 to northbound I-280 and would replace the existing Monroe Pedestrian Overcrossing. The purpose of the Project is to improve traffic operations on the local roadways, improve bicycle and pedestrian access and transit connectivity, and improve access from northbound I-280 in the project area.

## WHY THIS NOTICE?

This notice is to tell you that the Draft EIR/EA is available for you to review and provide comments. This notice also invites you to attend a public meeting on the project.



## PROJECT LOCATION

The proposed Project is located at the existing Interstate 280 (I-280)/Winchester Boulevard interchange and the adjacent State Route 17 (SR-17)/I-280/I-880 interchange, in San José, Santa Clara County, California, as shown in the map below.



## SIGNIFICANT ENVIRONMENTAL IMPACTS

The Draft EIR/EA identifies significant impacts to the following resources: air quality, biological, noise and vibration, and public services. With one exception, all impacts of the Project, both individually and cumulatively, would be less-than-significant with mitigation incorporated. The exception is the visual impact of the connector flyover ramp from northbound SR-17 to northbound I-280 on the view from the neighborhood along Parkmoor Avenue. This aspect of the Project, taken together with the recently constructed flyover ramp from northbound I-280 to northbound I-880 and new soundwalls, creates a substantial cumulative impact to views from Parkmoor Avenue. With the inclusion of mitigation measures, this impact would remain significant.

## HAZARDOUS MATERIALS

As required by the California Code of Regulations, Title 14, (State CEQA Guidelines) Section 15087, the presence of any sites listed on Section 65962.5 of the Government Code must be disclosed with this notice. The project area includes two gasoline service stations located on the corners of the Winchester Boulevard/Moorpark Avenue intersection that are included on this list. Please refer to Section 2.14 of the Draft EIR/EA for more information on these locations.

# Proyecto de Mejoramiento del Intercambio I-280/Winchester Blvd.

El Departamento de Transportes de California (Caltrans), como agencia líder del sector conforme lo establece la Ley de Calidad Ambiental de California (CEQA, por sus siglas en inglés) y la Ley de Política Ambiental Nacional (NEPA, por sus siglas en inglés), ha preparado un Borrador del Informe de Impacto Ambiental (EIR)/Evaluación Ambiental (EA) para el Proyecto de Mejoras al paso a desnivel entre la I-280 y Winchester Boulevard. ## ¿QUÉ SE PLANEA?

Caltrans, en cooperación con Santa Clara Valley Transportation Authority (VTA) y la ciudad de San Jose, propone modificar el paso a desnivel existente entre la I-280 y Winchester Boulevard mediante la construcción de un nuevo túnel para la rampa de salida desde el carril en dirección norte de la I-280 a Winchester Boulevard. El Proyecto también construiría una nueva rampa de conexión directa desde el carril en dirección norte de la SR-17 hasta la I-280 en dirección norte y reemplazaría el actual paso peatonal elevado de Monroe. El propósito del Proyecto es mejorar el tráfico en las vías locales, mejorar el acceso para bicicletas y peatones y la conectividad del transporte público, además de mejorar el acceso desde el carril en dirección norte de la I-280 en el área del proyecto.



El Proyecto propuesto está ubicado en el paso a desnivel actual de la Autopista Interestatal 280 (I-280)/Winchester Boulevard y el paso a desnivel adyacente de la Ruta Estatal 17 (SR-17)/I-280/I-880, en San Jose, Condado de Santa Clara, California; tal como se muestra en el mapa a continuación.



## **IMPACTOS AMBIENTALES SIGNIFICATIVOS**

El Borrador EIR/EA ha identificado impactos significativos que afectan a los siguientes recursos: biológicos, calidad del aire, ruido y vibración, y servicios públicos. Con una sola excepción, todos los impactos del Proyecto, tanto de manera individual como acumulativa, serían menos que significativos con la mitigación incorporada. La excepción es el impacto visual de la rampa elevada del conector desde el carril en dirección norte de la SR-17 hasta el carril en dirección norte de la I-280, que afecta la vista del vecindario a lo largo de Parkmoor Avenue. Este aspecto del Proyecto, junto con la rampa elevada construida recientemente desde el carril en dirección norte de la I-280 hasta el carril en dirección norte de la I-880 y los nuevos muros de protección acústica, crea un impacto acumulativo sustancial en la vista desde Parkmoor Avenue. Con la inclusión de medidas de mitigación, este impacto seguiría siendo significativo.



Ngoại lệ là tác động trực quan của đoạn đường nối cầu vượt từ hướng bắc SR-17 đến hướng bắc I-280 trên tầm nhìn từ khu phố dọc theo Parkmoor Avenue. Khía cạnh này của Dự Án, được thực hiện cùng với đoạn cầu vượt mới được xây dựng gần đây từ hướng bắc I-280 đến hướng bắc I-880 và các tường âm thanh mới, tạo ra một tác động tích lũy đáng kể đến tầm nhìn từ Parkmoor Avenue. Với việc bao gồm các biện pháp giảm thiểu, tác động này sẽ vẫn còn đáng kể.



## 重大環境影響

EIR/EA草案確定了對以下資源的重大影響：空氣品質、生物、噪音和振動以及公共服務。除了一個例外情況之外，該專案的所有影響，無論是單獨的還是累積的，如果納入緩解措施，都不會那麼大。例外情況是，從SR-17北行到I-280北行的連接立交匝道對沿著Parkmoor大道社區的視野產生了視覺影響。該項目的這一方面，加上最近建造的從I-280北行到I-880北行的立交匝道和新的隔音牆，對Parkmoor大道的視野產生了巨大的累積影響。即使納入緩解措施，這種影響將仍然很大。


