There was an extended discussion about the potential duties of a potential chairperson for the group. The discussion included whether it would be better to refer to the position as a spokesperson and how "consensus" might be defined. There was discussion regarding the benefits of having a Chair to communicate to elected officials. The CWG members also acknowledged that they were still able as individual members contact elected officials and other stakeholders separately if they were not the Chair or if there was not a Chair.

At the end of the discussion (condensed and summarized here with permission and direction from the CWG) the group agreed to the following duties and determined that Davide Vieira would serve as the Chairperson of the Alum Rock CWG.

CWG chairperson duties:

- liaise with the VTA-designated facilitator and/or staff in advance on the agenda for each meeting of the CWG,
- at the request of CWG members and in consultation with the facilitator and/or staff, add items to agendas,
- at the request of CWG members or at the discretion of the chair, negotiate deferring agenda items with the facilitator and/or staff,
- assist the facilitator in the management of meetings (but not chair the meetings), and
- Serve as spokesperson for the CWG as deemed appropriate by the full CWG.

Discussion notes for Work Plan:

Items discussed to be added to the Work Plan have been added as new topics or integrated into existing topics already shown on the Work Plan. The Work Plan will be updated quarterly to ensure relevant topics are presented at appropriate times with the current environmental activities.

- Presentation on the Berryessa Station parking. In Work Plan under station features and modeling items.
- Presentation on access studies and specifics of Alum Rock Station design especially as the design relates to surrounding potential transit oriented development. Also cover Kiss and Ride lot plans. *In Work Plan under station features and access planning items.*
- BART staff to present need for maintenance facility and justification of location of maintenance facility including why facility cannot be in Berryessa or another location. *This will be part of the BART staff's Operations and Maintenance Presentation*
- Financial Analysis as part of New Starts program, including operations and maintenance assumptions. *In Work Plan under New Starts Overview item.*
- Presentation on the evolution of the parking requirements/strategies since there are now about half the spots planned for Alum Rock than there used to be. Include discussion of whether lessening of parking impacts the viability of the

project and FTA's support. In Work Plan under station features and modeling items.

- Added to next month's discussion on ridership and modeling the specifics about what is the Route 101 access assumption to the Berryessa and Alum Rock Stations. Will be clarified with the group in the project status update in August
- Presentation of potential right-of-way impacts and relocations and a discussion on gentrification as a result of the BART project. In Work Plan under ROW Requirements for BART Phase II. Gentrification is not part of the scope of this project
- Present the demographics of the Alum Rock area (1 mile, ½ mile and ¼ mile). Present not just typical demographics but also social equity components such as existing transit ridership. *Action item from June CWG meeting*.
- Update on Five Wounds Trail. In Work Plan under next meetings discussion of other City projects.
- Presentation on marketing plan to generate new BART riders on this extension. In Work Plan.
- Convene a panel of developers/economists to discuss what can be done to make the Alum Rock area more attractive to developers and also what makes an area less desirable. *In Work Plan under City's economic analysis update.*
- Present project vibration impacts specifically as they relate to Five Wounds Church. *Present findings after the environmental analysis is complete.*
- Present how VTA does its contracting covering the topics of SBE/DBE outreach and local business outreach and preference. *In Work Plan.*
- Presentation on ridership assumptions and affordability, potential for fare integration and subsidies. *This will be discussed at a BART Board meeting and an update provided to the VTA Board will inform the CWG, VTA does not set the fares for the BART system.*
- Impacts to Christo Rey School site during construction including dust, noise and impacts form station box construction. *Present findings after the environmental analysis is complete*.
- How will the community near the Tropicana Shopping center access the Alum Rock Station, specifically bike riders' ability to navigate the hill. *Not in project area.*
