When will the VTA BART Phase I be open?	Construction on BART Phase I is 97% complete.
When will the VTA BARTT hase the open:	VTA is now in the system testing phase where the
	new extension becomes fully integrated with the
	existing BART system. During this phase, things
	can change more frequently and affect the pace of
	the work. The original project schedule for start of
	passenger service was summer 2018. VTA has
	tracked months ahead of schedule for most of the 5
	years of construction and was anticipating an
	opening date of December 2017. However, based
	on the outcome of the system testing work that both
	BART and VTA will perform over the next couple of
	months, we hope to share a reforecast opening

	date this fall.
Will the bus and LRT changes outlined in Next Network happen when the new stations open?	Yes, that is the intent.
Milpitas Station	
Why are there no crosswalks?	There will be a pedestrian overcrossing built to connect the community on the other side of Montague to the station.
How much retail is provided for here at the Station? When will it be open?	Six thousand square feet. It is configured in two or three units. The VTA Real Estate Department will negotiate with tenants about six months ahead of the Station opening.
What is the expected ridership for the Milpitas Station?	The opening day estimate is 12,000 riders a day.
Where is bike storage?	There is a bike storage room in a separate building next to the Station.
How will the electric car charging be handled? I have seen cars hog the chargers.	Vehicles using the electric car charging stations will be allowed to park in the space for the duration of their trip, however long it may be, and they will be charged an hourly rate while their vehicle is charging in addition to the daily parking fee. VTA has the ability to expand the number of electric vehicle charging stations to up to four times as many spaces as each campus will start with.
Berryessa Station	
Are these buildings condos or apartments?	The residential properties along Salamoni Court are townhomes.
Explain why there is a police station building?	Because Berryessa Station is the end of the line station for a period of time.
Will there be more houses around here eventually?	The City of San Jose has approved a plan for housing on the current Flea Market property. The entitlements to build exist. It is up to that private property owner to determine when that housing would be built.
What is the three-story structure?	That is the end of the line operations booth just like the one we saw at the Warm Springs/South Fremont Station.
Are there sustainable features?	Electric car charging, bio-swales for drainage, solar panels, low VOX paint, drought tolerant native landscaping to name some of them.
Why isn't there retail at this station?	In Milpitas it was a requirement and it was not a requirement at this station. Under the old FTA guidelines adding non-required elements negatively impacted a project's rating.
