Where will the April 22 <sup>nd</sup> VTA Board Workshop be held?	The Workshop will be held at VTA's offices 3331 North First Street in San Jose in the Auditorium. The meeting will start at 9:00 a.m.
Process for determining East versus West Downtown Station Update	
Are the criteria weighted?	All criteria will be considered. The City's preferred option will be a big factor. The biggest issue is where does the City want to grow from and use as its core?
Will you wait until after the draft SEIS/SEIR is released to have a VTA recommendation and decision?	Yes. The final project scope including the downtown station location will be decided by the VTA Board in December 2016 or early 2017, not before. The sales tax funding is also a factor.
Do you want the CWG to discuss their preferences at this meeting?	No. The environmental information about the two options is not yet available. It is more appropriate for the CWG members to speak directly to the Board when the project description is on the agenda in December 2016 or early 2017. We will have a discussion about how and when to comment on the SEIS/SEIR on a future CWG agenda.
The Downtown Association Board has taken a position to support the west option for the station and the cross over track east of Diridon.	Comment noted.
Economic development and connectivity should be top considerations and should be in that order on your slides.	Comment noted. We'll add these revisions as an action item.
Walkability and accessibility to jobs – where is that taken into consideration?	Under connectivity.
What does long term economic development actually mean in this case?	This considers where the best opportunities are to have the community develop and support the system.

It really should say "short term" VTA infrastructure impacts since you are looking at bus bridge during construction in that item.	Good point that will be added.
Is the cost estimate quantitative or qualitative?	Qualitative; the options are very close in cost.
What is the City's opinion about station location?	The City is leaning toward the west station option.
Public comment regarding additional option submitted in scoping process that would save downtown from many of these impacts.	We will address what happened to all scoping suggestions in next agenda item.
When the options and trade-offs are more fleshed out can staff bring this back to the CWG?	Yes. We will add this to the CWG workplan.
Diridon Intermodal Study	
Can VTA distribute Diridon Multi-modal Study Phase 1 scope to CWG members when available?	Yes.
What does consultant need to know to develop operating plan?	The Diridon consultant team will need to know how each service intends to operate. That is why it is a good thing that high speed rail is advancing its planning effort at this time.
Will customer experience be an element that is studied?	Yes.
Environmental Process Update	
What did you mean by an "outlier issue" that could impact the document's schedule?	An example would be a previously unknown cultural resource such as burial grounds or a previously unidentified historic building.
Economic Analysis Update	
The City of Santa Clara recently lost a project near the proposed BART Station/existing Caltrain Station. Will that be looked at?	No. This report is being sponsored by the City of San Jose and is only looking at the impacts and opportunities at the three San Jose station locations.
Did the Nelson Nygaard Station Access Study look at the pros and cons of the two downtown station options? Can we get a copy of that information?	They did some analysis and yes we will send you the link when the report is posted on-line.

The City will look seriously at any and all suggestions from the developers. A decision about the box construction would need to have the concurrence of VTA and likely BART staff for it to move forward.
