

# **Draft Supplemental Environmental Impact Report BART Extension Project**

### Lead Agency: Santa Clara Valley Transportation Authority

## PROJECT DESCRIPTION AND LOCATION

The BART Extension Project, formerly named the Silicon Valley Rapid Transit Corridor (SVRTC) Project, consists of a 16.1-mile extension of the Bay Area Rapid Transit (BART) system from the planned Warm Springs Station in Fremont through Milpitas and San Jose to Santa Clara. See Exhibit 1.

## SUPPLEMENTAL ENVIRONMENTAL IMPACT REPORT

The Santa Clara Valley Transportation Authority (VTA) intends to prepare a Draft Supplemental Environmental Impact Report (Draft SEIR) for the BART Extension Project in accordance with the California Environmental Quality Act (CEQA).

The Draft SEIR will evaluate the proposed project design changes and changes to the regulatory and environmental settings that have occurred since the certification of the Final Environmental Impact Report (FEIR) in December 2004. Generally, the changes include: (1) vertical and horizontal alignment changes: (2) station consolidation in Downtown San Jose; (3) revised station designs and configurations; (4) additional project information; (5) changes in the existing project setting; (6) revised forecast year of 2030; and (7) project schedule changes.

#### ENVIRONMENTAL PROCESS BACKGROUND

In February 2002, VTA initiated the environmental process by conducting scoping meetings for the SVRTC Project. In March 2004, the Draft Environmental Impact Statement/Draft Environmental Impact Report (DEIS/DEIR) was released for public review in accordance with state and federal law. The FEIR was certified by the VTA Board of Directors on December 9, 2004. Following certification of the FEIR, project design continued through the preliminary engineering phase. Alterations and refinements to the project were proposed to reduce environmental concerns, improve operations, incorporate new data, or reduce costs. These proposed changes to the certified project have made it necessary to prepare a SEIR.

The federal environmental document, the DEIS, continues to be processed separately and is scheduled to be completed in 2008.

## **PROBABLE EFFECTS**

The purpose of the SEIR is to fully disclose the environmental consequences of the proposed changes described above. The SEIR will explore the extent to which the changes result in environmental impacts and will discuss actions to reduce or eliminate such impacts. Environmental issues to be examined in the SEIR include: the physical environment (air quality; biological resources and wetlands; electromagnetic fields; energy; geology, soils, and seismicity; hazardous materials; noise and vibration; utilities; visual quality and aesthetics; water resources, water quality, and floodplains); the social environment (community services and facilities; land use; security and system safety; socioeconomics); transportation and transit, including parking, pedestrians, bicycles, and traffic; and cultural and historic

resources. Impacts resulting from the project and setting changes will be identified for both the longterm operation of the project and the construction period. The proposed evaluation criteria include transportation, environmental, social, and economic measures, as required by current state (CEQA) environmental laws. To ensure that the full range of issues are addressed and all significant impacts identified, comments and suggestions are invited from all interested parties. Comments or questions concerning these issues should be directed to VTA as noted below.
