





Remember:

- **Section 1.4** states that "All Bids shall be enclosed in a <u>sealed</u> <u>envelope</u> bearing the Contract number, the title of the Project, the date and hour of the Bid opening, and the name of the Bidder."
- **Section 3.11.1** states that "Bids received after the Bid Opening will not be considered. A late Bid will be returned to the Bidder unopened."

SUBMISSION OF BID

- Bring your Bid package to the Lobby of Building A.
- It is recommended that your Bid package is hand-carried.
- Make sure your Bid package is date and time stamped by VTA Receptionist at the Front Desk.
- Bid Forms that are not legible will be considered Non-Responsive.









TIME FOR PERFORMANCE

• As per **Section 6.4**, the base term of the Contract is one year (the "Base Year"). The first day of the Base Year will commence on the date the Contract is executed.

SBE GOAL

> License Requirements



 Contractor must, at the time of Award, possess current licenses in the following classifications issued by the California Department of Consumer Affairs, Contractors State License Board:

License: Class A and C-27 or Alternative 1: C-27 and/or C-61/D-49

- A combination of prime Contractor and subcontractor license is acceptable only when each subcontractor's scope of work is identified in **Bid** Form 3 and each subcontractor is properly licensed at the time of Contract award.
- Regardless of whether a subcontractor must be identified at the time of Bid, each subcontractor must also be properly licensed to perform its scope of work.

BID FORMS

Your Bid package must contain 10 Bid Forms.

- <u>Bid Form 1</u>: Schedule of Quantities and Prices, Contractor Information
 - Base Year (10% of this amount is to be used for Bidder's Bond)
 - ➤ Option Year 1
 - Option Year 2
 - ➤ Option Year 3
 - Option Year 4
- <u>Total Bid Price</u> = Base Year + Option Year 1 + Option Year 2 + Option Year 3 + Option Year 4
- As per Section 2.3.2, the Contract will be awarded to the lowest responsive Bid and responsible Bidder ("Successful Bidder"), based on the "Total Bid Price".
- The Engineer's Estimate for the Work in this <u>5-year</u> contract ranges from to \$3,790,000 \$5,450,000.

- <u>Bid Form 4</u>: Listing of SBE Contractor or Subcontractors
- <u>Bid Form 5</u>: Supplemental Contractor and Subcontractor Information

Insurance Requirements

INSURANCE
REQUIREMENTS

Winning Bidder

- General Liability (GL): \$2M (including umbrella/excess liability)
 - > \$2M must be the GL primary policy limit per occurrence.
- Automobile: \$1M (including umbrella/excess liability)
 - > \$1M must be the Automobile primary policy limit per occurrence.
- Workers' Compensation: \$1M per accident.
- Contractor's Pollution Liability: \$2M per occurrence.
- <u>Umbrella policies:</u> if used, must have Drop Down and Follow Form provisions, and effective date concurrent with underlying policies.





>Insurance Requirements

INSURANCE REQUIREMENTS (Appendix A)

Insurance Certificate

- ➤ In the "Description of Operations" box, you must refer to the Contract No. M19135 and the Project Title "Landscaping Maintenance Services".
- Must include copies of all endorsements required in Appendix A.
- Must disclose all deductibles or self-insured retentions.
- ➤ Deductibles greater than \$50K must be declared to and approved by VTA (Submit last three years' Income Statement & Balance Sheet.)
- Any exceptions to Appendix A must be submitted with IFB response.
- Insurance must be in place and approved by VTA prior to contract Notice To Proceed (NTP).
- The renewal certificates must be submitted to VTA within ten (10) business days from the expiration of insurance.

DESCRIPTION OF WORK

For purposes of this Contract, the Work consists of furnishing all labor, materials, tools, equipment, services, supervision, and incidentals necessary to (a) maintain the landscape(s) in an attractive condition; (b) maintain the irrigation systems in effective working order; and (c) perform weed abatement as needed, throughout the Contract term for all locations identified in these Contract Documents.

The Contract is for one Base year with four 1-year options.

The Work will be conducted within an operating rail yard and adjacent to and within existing shop facilities. This Work will be subject to restrictions to ensure safety and the continuing operations of the yard and shop and the light rail system.

The Engineer's Estimate for the Work in this 5-year contract ranges from to \$3,790,000 - \$5,450,000.
